SUBJECT: Updated Mayo Clinic Routing Instructions

EFFECTIVE DATE: November 1, 2013

This updated Mayo Clinic Transportation Routing Guide provides instructions for shipping products to participating Mayo Clinic locations. Mayo Clinic will not pay shipping charges for orders not shipped in accordance with this routing guide unless contractually required or prior authorization is granted. This includes direct from manufacturer drop shipments. Vendors currently shipping prepaid and add are expected to convert to Mayo Clinic's Inbound Logistics Program.

SHIPPING TERMS: FOB Destination; Small Package Shipments = Bill Third Party; Freight (LTL) Shipments = Bill Collect

PACKAGING REQUIREMENTS: All shipments containing a piece heavier than 75 pounds must be shipped on a skid and sent via FEDEX Freight (LTL) Economy. For multiple pieces being shipped on a skid, do not stack product more than 66 inches tall.

APPROVED TRANSPORTATION CARRIERS:

For Domestic Shipments

- **FEDEX Ground:** Vendor should bill 3rd party using account number **(call 507-266-5551 for number)**, when each single piece/box is 75 pounds or less, and the total shipment is 300 pounds or less, and number of cartons is 20 or less. Express (expedited) services are authorized only when specifically requested by the buyer.
- **FEDEX Freight (LTL) Economy:**
 - When a single piece/box is more than 75 pounds, or
 - total shipment is more than 300 pounds, or
 - when order is more than 20 cartons

Vendor should **Bill Collect** using bill to address of: **Mayo Clinic, 200 1st Street SW, Rochester, MN 55905-0001**. When Bill Collect is indicated on a Freight (LTL) shipment, an account number is not required. The use of Bill Collect still allows an option of shipping to a different Mayo Clinic location than the bill to location. Freight Priority (expedited) services are authorized only when specifically requested by the buyer.

For International Shipments

- Mayo Clinic's broker is FedEx Trade Networks.
- **FEDEX International Economy:** Vendor should bill 3rd party using account number **(call 507-266-5551 for number)**, when each single piece/box is 75 pounds or less, and the total shipment is 500 pounds or less.
- **FEDEX International Economy Freight:** Vendor should bill 3rd party using account number **(call 507-266-5551 for number)**, when a single piece/box is more than 75 pounds or the total shipment is more than 500 pounds.

DOCUMENTATION REQUIREMENTS: Mayo Clinic requires the purchase order number be clearly posted in the reference field of the air/freight waybill. The packing slip should be affixed to the outside of the package, and the

invoice sent to the address noted on the Purchase Order. Failure to include the PO number on all documents, including the air/freight waybill, will delay acceptance of delivery and/or payment of invoices.

PICKUP AND DELIVERY REQUIREMENTS:

- **Pickup:** Vendors are responsible for arranging the pickup of shipments. Any pickup charges are the responsibility of the vendor.
- **Delivery:** No weekend or after hours deliveries allowed unless agreements are made with buyer prior to shipment.

DECLARED VALUE: Mayo Clinic is self-insured and highly discourages vendors from assigning declared value on shipments shipped on the inbound logistics program.

COMPLIANCE: These instructions supersede all previous shipping instructions. All incoming shipments and invoices will be monitored, and any deviation from these instructions will result in a charge back of the shipping costs.

ACCOUNT CONFIDENTIALITY: FedEx account numbers are confidential and should only be communicated for the limited purpose of preparing FedEx shipments under these routing instructions. Do not post this information online or make it generally available beyond what is required for your company to follow the instructions. Mayo Clinic's transportation account numbers should be used for Mayo Clinic shipments only. These accounts are monitored for abuse and Mayo Clinic will not pay invoices for unauthorized charges associated with our accounts or credit line.
